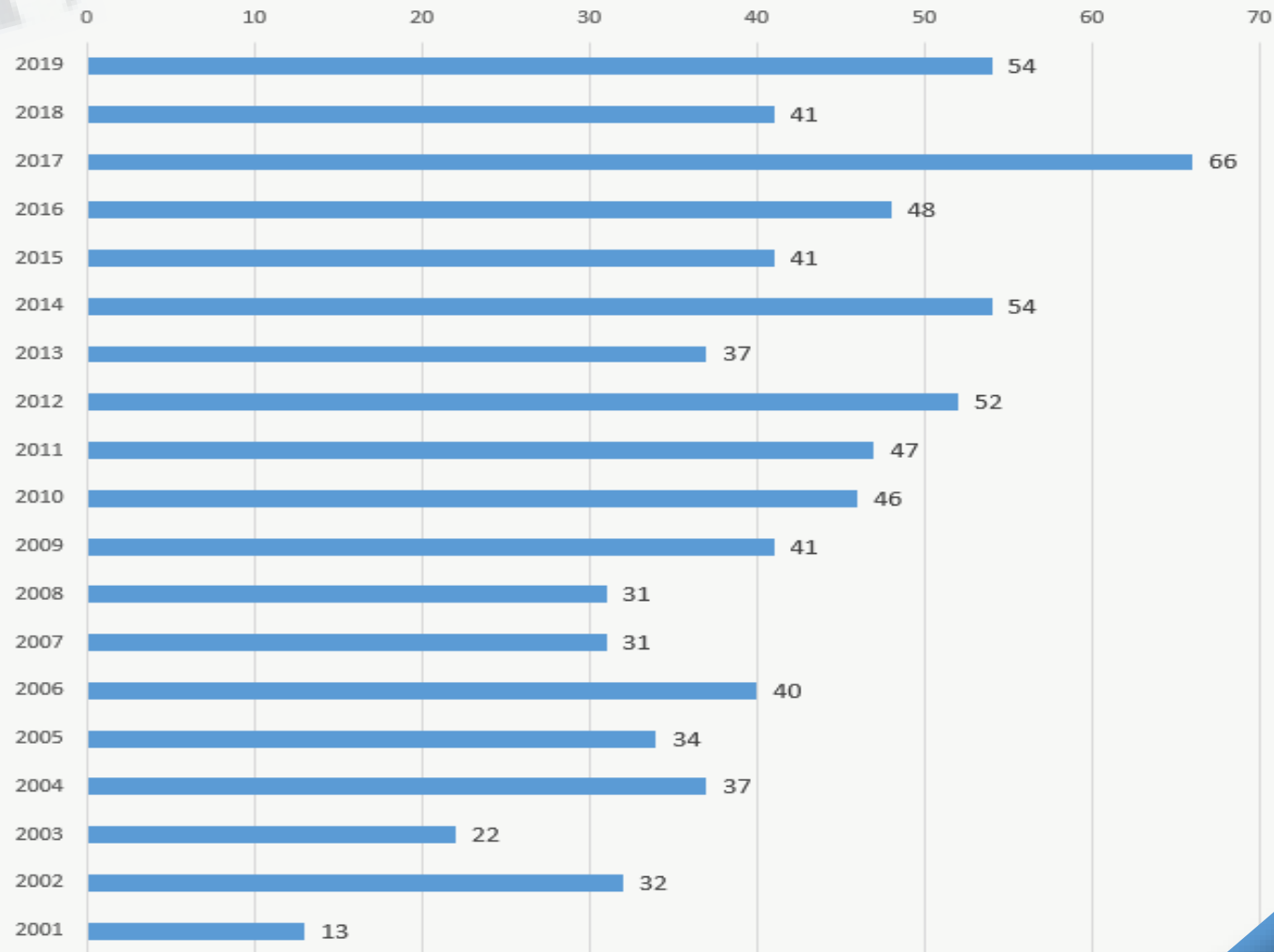

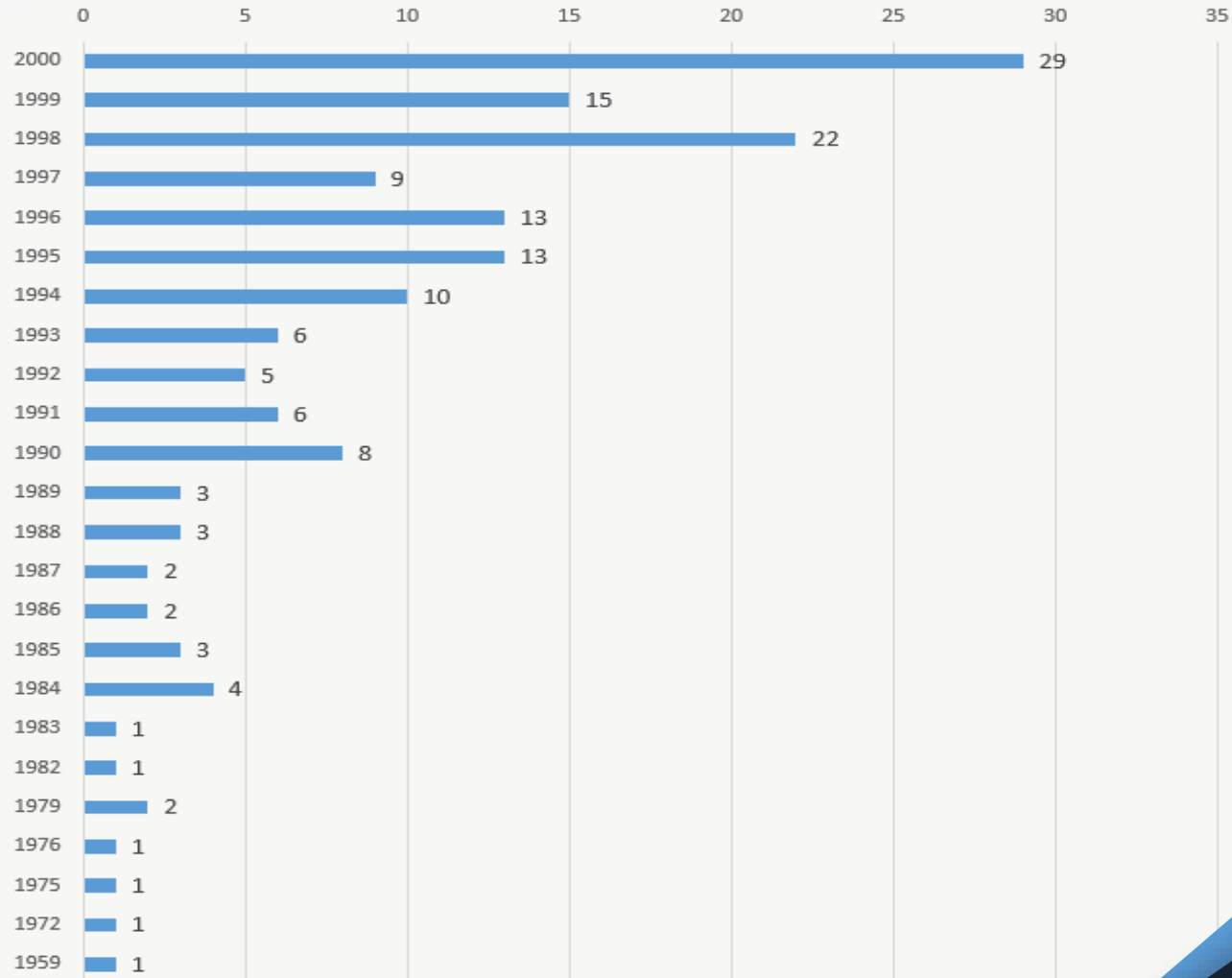
- Currently there are 928 liable Staffing Companies registered with SCDEW



Employer Liability Dates



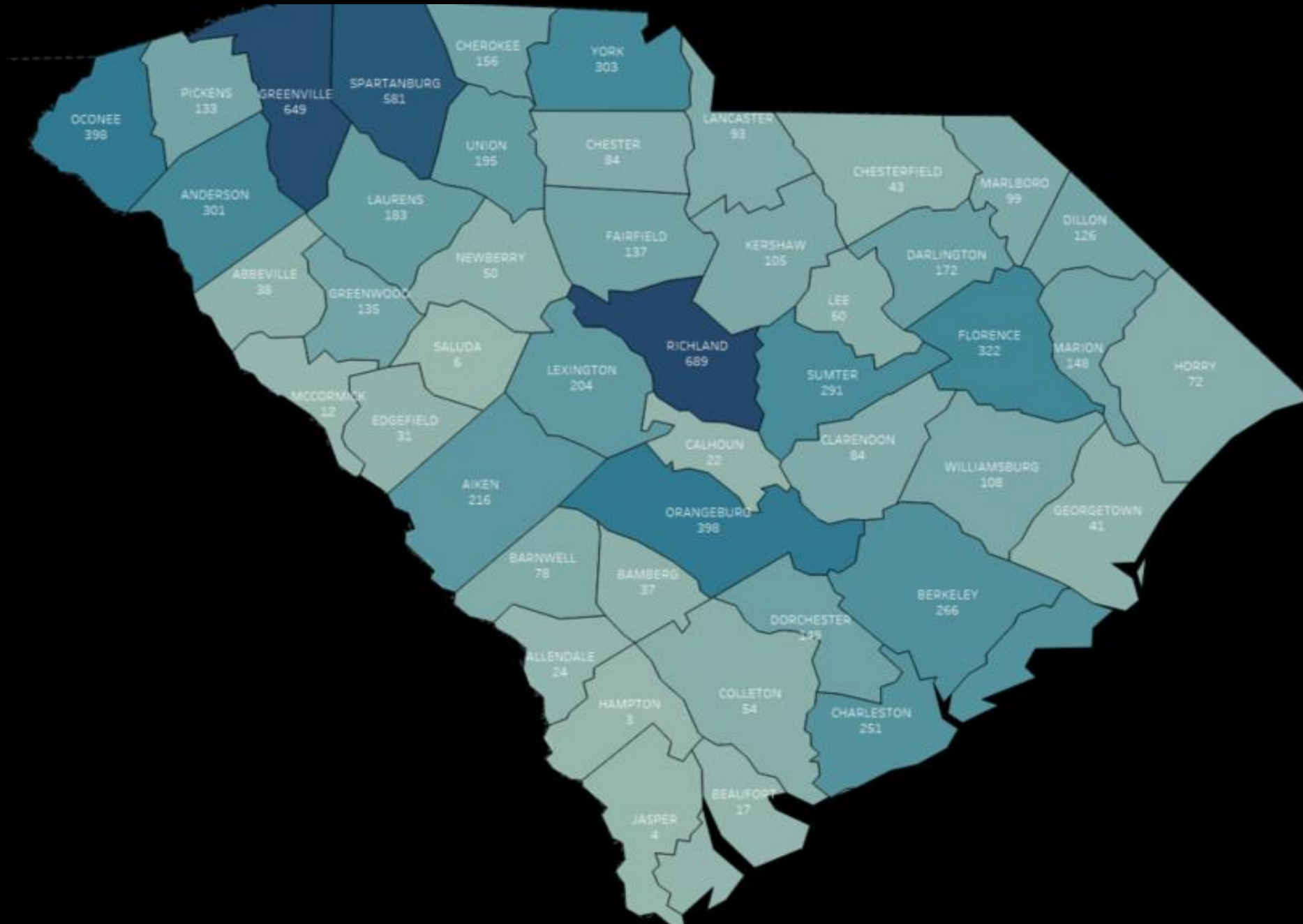

Claims Filed

- In 2019, there were 121,966 initial unemployment claims filed in South Carolina
- 7,794 of those claims were filed due to a separation from a Staffing Company
- In 2019, 380 Staffing companies had at least one unemployment claim filed by a former employee



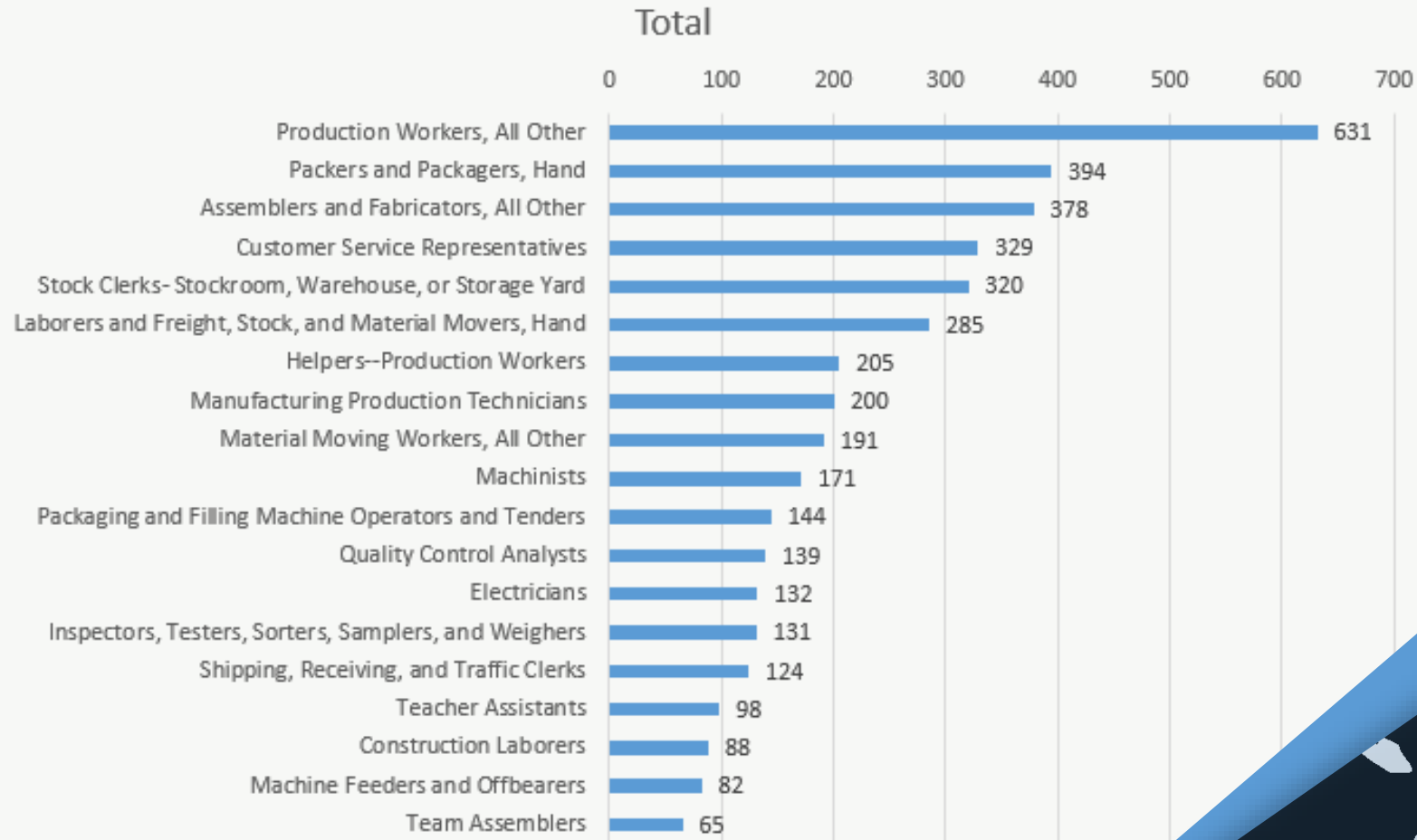
Separation Reasons

- Voluntary Quit 10%

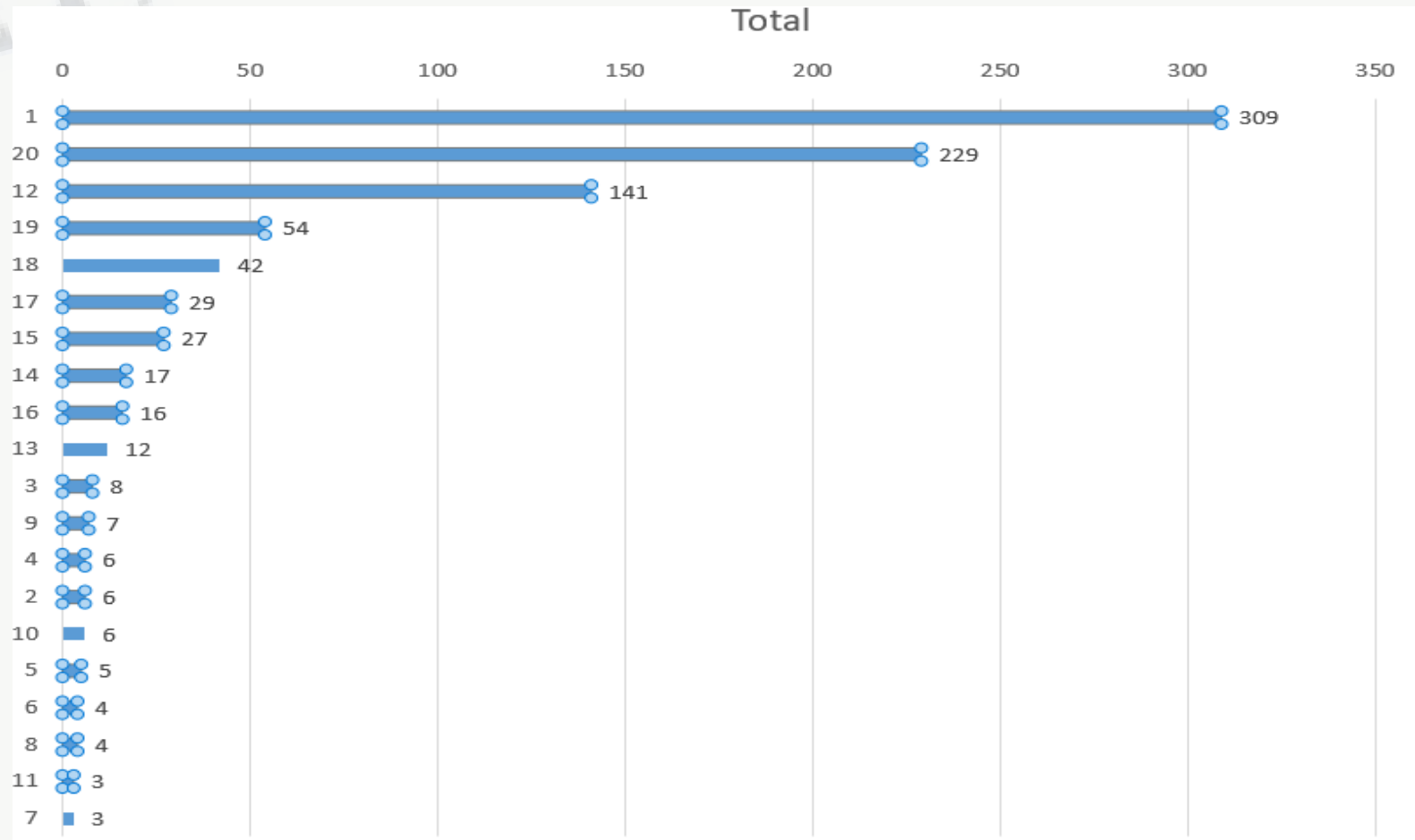




Occupation Graph

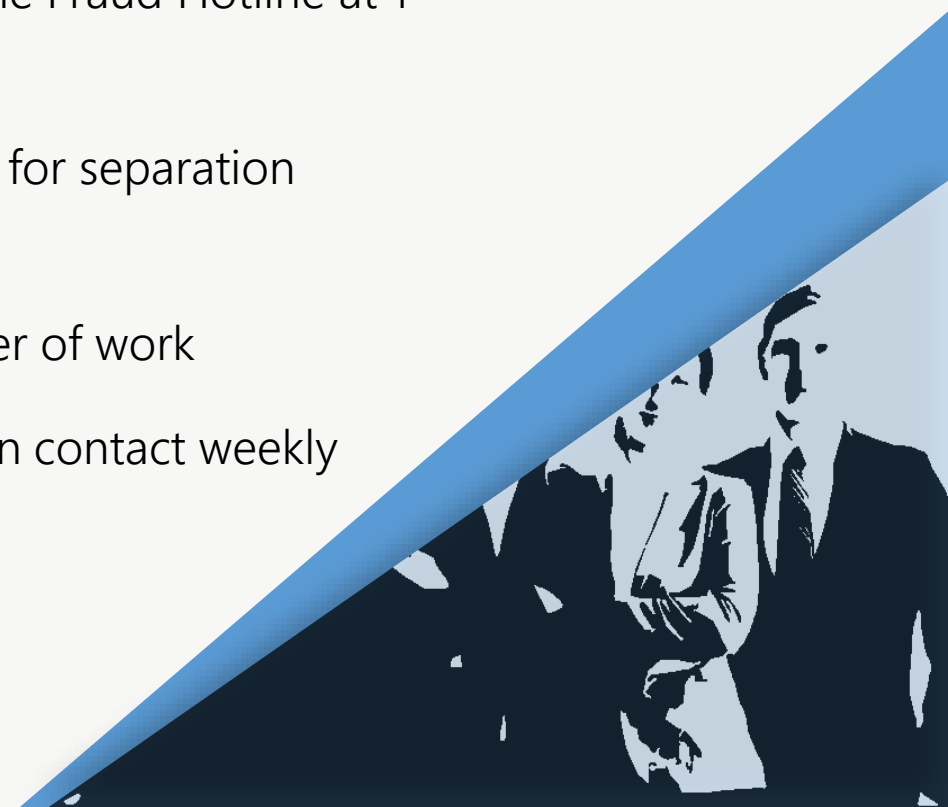

- Inform SCDEW if a former employee fails to maintain contact weekly
- Review charges against your account
- Respond to Wage Audit Notices
